## 72.0. GRAND GULF BILL CREDIT

### 72.1. PURPOSE

The purpose of this rider is to provide Arkansas retail customers with a one-time bill credit associated with the global settlement between System Energy Resources, Inc. and the Arkansas Public Service Commission filed at the Federal Energy Regulatory Commission ("FERC") in November 2023, approved on March 21, 2024, and the partial settlement in FERC Docket No. EL20-72 approved by FERC in May 2023.

### 72.2. APPLICATION

GGC applies to customers taking service under the rate schedules listed in Section 72.3., including rates under Special Contracts, subject to the jurisdiction of the Arkansas Public Service Commission. If a customer takes service under more than one rate schedule listed in Section 72.3, the credit associated with the primary rate class for electric service will be applied, provided, however, that in no event will a customer receive more than one bill credit.

Total charges for the month of August 2024 will be reduced by the credit in 72.3. If the credit is greater than a customer's total charges for August 2024, the excess credit will carry over to subsequent billing months only until such time as the remaining portion of the credit is fully realized.

The credit will appear as a line item on the August 2024 bill titled, "Grand Gulf Bill Credit."

### 72.3. RATE DETERMINATION

EAL determined the credit amount by allocating the total refund amount associated with the settlements identified in 72.1 among the applicable Rate Classes based on the revenue requirement approved in APSC Docket No. 15-015-U and calculating a one-time credit for each class based upon the number of accounts for each class as of December 31, 2023. This one-time credit will be applied to customers' bills for the August bill cycle rendered on and after the first billing cycle of August 2024 for those customers taking service as of December 31, 2023.

The amount of the credit to be provided, by Rate Class, is as follows:
